**COMMONLY ASKED  
QUESTIONS and ANSWERS**

**Question: What does the Comprehensive Eye Examination include?**

**Answer:** Refraction and additional tests for glasses, eye health evaluation including glaucoma screening, eye muscle function testing, recommendations and prescriptions.

**Question: Do I need to have my eyes dilated, and can I drive afterward?**

**Answer:** Dilation drops are used to obtain a better view of the interior of your eyes. The blurring effect lasts about 6 hours. Most people can drive in familiar areas, but not after dark. To be safe, bring a driver with you. We recommend dilation at your first exam and periodically thereafter. In some cases, if you choose to have the Optomap retina scan (additional fee of \$39.00), a dilation exam might not be necessary.

**Question: What does a Contact Lens Examination include?**

**Answer:** A Contact Lens Examination includes the Comprehensive Eye Examination plus other tests and measurements to help determine which contact lenses would be best suited to your particular needs. It also includes two follow-up visits within three months of the date of the examination.

**Question: Can you give me a prescription for eye medications?**

**Answer:** Yes. Dr. Hornstein is certified to treat eye conditions that require oral medicines or eye-drops such as antibiotics. He prescribes treatments for allergies, infections, inflammation and glaucoma. In some cases you will be referred to an appropriate specialist for treatment.

**Question: Is payment required at the time of the examination?**

**Answer:** The professional fee is to be paid in full at the time of the examination. For your convenience we accept:

- Personal checks
- Cash
- Credit and Debit cards
- Care Credit

**Question: What vision insurance do you accept?**

**Answer:** We accept most plans including EyeMed, VSP, Aetna, Medical Eye Services, and Medi-Cal. We accept Medicare for non-routine eye exams and treatment. We will try to reach your insurance carrier to determine if you are eligible for coverage in advance of your appointment.
